  - □ Law enforcement safety or training course or class offered for security guards, investigators, or special deputies
  - U.S. Armed Forces may submit a copy of DD-214 (Long Version Only)
  - Firearms safety or training class available to the general public offered by a law enforcement agency, state college or private institution who utilize certified instructors

#### ADDITIONAL DOCUMENTATION, IF APPLICABLE

- All legal documents that reflect a name change i.e., marriage certificate, divorce decree, court order, etc.
- Certified copies of court documentation reflecting the final disposition of any convictions or adjudications withheld
