## 1 of the following valid Identification Documents:

- State-issued driver license or identification card
- US Active duty/retiree/reservist Military ID card
- US Passport
- Foreign Passport with appropriate immigration documents
- US Tribal or Bureau of Indian Affairs ID card
- US Permanent Resident Card

### Additional documentation, if applicable

- Concealed weapon or firearm license number  
*This information is contained on the applicant's renewal notice and on the Concealed Weapon or Firearm License.*
- All legal documents that reflect a name change i.e. marriage certificate, divorce decree, court order, etc.  
*Credential with name change will be mailed by FLDACS within 90 days*
- Certified court documentation reflecting the final disposition of any convictions or adjudications withheld
- Any applicant born outside the United States must provide documentation from United States Citizenship and Immigration Services (USCIS) proving US Permanent Resident or US Citizen status (such as US Permanent Resident Card, US Passport, Certificate of Citizenship, Consular Report of Birth, etc.)

### Payment Options:

- Debit card
- All major credit cards

Checks must be made payable to the Lee County Tax Collector.

A convenience fee is charged when using a credit or debit card and is subject to service provider rates which may vary. No portion of this fee is retained by the Lee County Tax Collector's office.

## 1 of the following Training Documents:

- Approved hunter education or safety course
- National Rifle Association firearms safety or training course
- Any training or safety course conducted by NRA certified instructor
- Law enforcement safety or training course or class offered for security guards, investigators, or special deputies
- Active duty military personnel with copy of military orders including call to active-duty letter or a statement of military service providing identity information and date of entry for current active-duty period  
*(it must be signed by, or at the direction of, the adjutant, personnel officer or commander of unit or higher headquarters)*
- U.S. Armed Forces may submit a copy of DD-214  
*(Long Version Only)*
- Firearms safety or training class available to the general public offered by a law enforcement agency, state college or private institution who utilize certified instructors

### Important Information:

- Bringing an interpreter is recommended as the Florida Department of Agriculture (FDACS) does not provide translation for the application questions
- For out-of-state reciprocity and concealed weapon licenses replacements, please visit [www.fdacs.gov](http://www.fdacs.gov).
- For Renewal applications, out-of-state residents will be fingerprinted prior to renewal of their concealed weapon license and the credential will be mailed from the Florida Department of Agriculture and consumer services (FDACS).
