

# Important Information about your Temporary Driving Permit

- This temporary permit should be carried with your photo identification (ex. previous driver's license or identification card, valid passport, or work authorization card).
- This permit is to be used in place of a driver's license or learner's permit until your hard card is received in the mail, all applicable rules apply.
- If you received this permit because you are waiting for FLHSMV to review and approve your driver's license transaction, please wait until the last week this permit is valid to allow enough time for your license to be approved and mailed.
  - An appointment is recommended, visit **LeeTC.com**
  - Please bring an interpreter, if needed.
- If you return to the office to apply for an extension of this temporary permit or to follow up on the transaction that was processed, you must bring all primary, secondary, legal presence, and residential address documents.
- We do not recommend completing any additional testing (ex. road test) while waiting for this license to come in the mail, as you must wait for this license to be received prior to an upgrade.
