YOU ARE CONSIDERED A FLORIDA RESIDENT ONCE YOU HAVE:

-  Started a job in Florida
-  Enrolled your child(ren) in a Florida public school
-  Registered to vote in Florida
-  Filed for homestead exemption on property in Florida
-  Lived in Florida for a period of more than six consecutive months



HERE ARE SOME STEPS TO TAKE AS A NEW FLORIDA RESIDENT:

-  Obtain insurance on your vehicle from a Florida agent licensed to sell insurance in our state.
-  After obtaining Florida insurance, register all currently owned vehicles/vessels in Florida. A physical VIN inspection is required for motor vehicles that do not currently have a Florida title.
-  Obtain your Florida Driver License or ID Card within 30 days of becoming a Florida resident. Visit **LEETC.com/document-requirements** for the specific documents you will need to bring with you.
-  File an application to register to vote while getting your Driver License through Florida's Motor Voter program. If you have questions about voting, visit the Lee County Supervisor of Elections website at **www.lee.vote**.
-  Property taxes in Florida are billed each November and due the following March. Sign up at **LEETC.com** to receive your property tax bill by email and apply to make quarterly installment payments if you choose.
-  If you have purchased a home, visit the Lee County Property Appraiser's Office at **LeePA.org** to file for Homestead Exemption and other tax relief.
-  If you have a business, obtain your Business Tax Account prior to offering goods or services at **www.lee.county-taxes.com/btexpress**.
