Upon completion of a title application, the Florida title will be maintained electronically by the Florida Department of Highway Safety and Motor Vehicles per Florida Statute 319.27.

Additional Required Items from Owner / Lessee:

- The vehicle to be titled must be present or submit a completed HSMV Form 82042 Vehicle Identification Number and Odometer Verification. Inclement weather conditions may delay vehicle identification number (VIN) verifications performed at our offices. The form can be located on our official website at www.leetc.com/formsdocuments
- Proof of current Florida insurance
- Each title applicant must be present with their valid government issued identification (see below), or an appointed Power of Attorney must present an original or a certified copy of the Power of Attorney document (along with their own identification) and a copy of the applicant's identification
- If your vehicle was purchased within the last six months, you must submit proof of purchase price and proof of sales tax paid. Additional taxes equivalent to Florida's sales tax or local tax may be due
- If your vehicle is titled in the State of Kansas form TR42 is required to be submitted along with this letter

Acceptable Proof of Identification:

- A valid driver license or identification card issued by Florida or any US Territory
- A valid Canadian driver license or identification card
- A valid passport or passport card from any country
