The following items are required to be submitted to Lee County Tax Collector:

- **A copy of this letter**
- The **original paper certificate of title** with the date of the lien
- **Typed or written document including the following information:**
 - ① The complete name and address of the lienholder and/or lessor
 - ② The Florida DMV Account Number or Federal Employer Identification Number for lienholder or lessor (if either is an individual a photocopy of the individual's state issued ID or Driver License must be submitted)
- **For leased vehicles, the following must be submitted:**
 - ① Original Power of Attorney (lessee to sign on behalf of lessor for titling purposes)
 - ② Florida Sales Tax Registration Number
 - ③ A copy of the lease agreement listing the lessee's name(s)

Instructions for Completing Request Letter by Owner/Lessee:

- ❶ Enter the requested information in the corresponding spaces as indicated.
- ❷ Select the service center location where you prefer to process your application at the bottom of the form.
- ❸ Keep a copy of this letter for your records and submit the original form to your lienholder or leasing company. Contact your lienholder / leasing company after 1 week of submission to verify receipt or if you have any questions regarding the date they mailed the paperwork to us.
- ❹ Our office will notify you by mail when the title is received with instructions.

Note: *If your vehicle is titled in the State of Kansas form TR42 is required to be submitted along with this letter.*

Important information:

This letter has instructions for your lienholder / leasing company for submission of your documents.

Additional Required Items from Owner/ Lessee:

- Vehicles with an out-of-state title must be present or provide an original completed HSMV Form 82042 Vehicle Identification Number and Odometer Verification. Note: Inclement weather conditions may delay vehicle identification number (VIN) verifications performed at our offices. The form can be located on our official website at www.leetc.com/forms-and-documents/.
- Proof of valid Florida insurance for this vehicle.
- Each title applicant must be present with their valid identification (see below), or an appointed Power of Attorney must present an original or a certified copy of the Power of Attorney document (along with their own identification) and a copy of the applicant's identification.
 - A valid driver license or identification card issued by Florida or any US Territory
 - A valid Canadian driver license or identification card
 - A valid passport or passport card from any country with a stamp or mark affixed giving evidence of lawful legal presence in the US
 - A current Permanent Resident card
- If your vehicle was purchased within the last six months, you must provide proof of purchase price and proof of sales tax paid, if applicable. Additional taxes equivalent to Florida's sales tax or local tax may be due.
